ORDINANCE NO. *SP4-201603*

AN ORDINANCE VACATING A PORTION OF TWO ALLEYS, PART OF THE FIRST ADDITION TO THE TOWN OF HAWK POINT, MISSOURI, AS SHOWN IN PLAT BOOK 2, PAGE 31, OF THE LINCOLN COUNTY, MISSOURI RECORDS.

WHEREAS, at its regular meeting on July 5, 2016, the Board of Aldermen of the City of Hawk Point, Missouri, upon its own motion, resolved to vacate the following described street, lying and being situated in the City of Hawk Point, County of Lincoln, State of Missouri:

ALL OF THE ALLEY IN BLOCK 5 IN THE FIRST ADDITION TO HAWK POINT, LINCOLN COUNTY, MISSOURI, RECORDED IN PLAT BOOK 2, PAGE 31.

ALL OF THE ALLEY IN BLOCK 6 IN THE FIRST ADDITION TO HAWK POINT, LINCOLN COUNTY, MISSOURI, RECORDED IN PLAT BOOK 2, PAGE 31.

WHEREAS, a public hearing regarding the proposed vacation of the alleys was set for July 5, 2016, at 6:00 p.m. and notice thereof was published in three public places and sent to all adjoining landowners.

WHEREAS, a public hearing regarding the proposed vacation of the alleys was had on July 5, 2016, at 6:00 p.m.

WHEREAS, the Board of Aldermen of the City of Hawk Point, Missouri, find as follows:

1. Farmers Elevator and Supply Company of Hawk Point, Inc. is the owner of the properties through which the alleys run.
2. The public has not used the alleys for at least 25 years.
3. No other adjoining landowner of the alleys described herein opposed the vacation of the alleys.

4. The vacation of the alleys will cause no injury to the public or adjoining landowners.
5. It would be in the best interests of the City to vacate the alleys.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF HAWK POINT, MISSOURI, AS FOLLOWS:


The following described alleys, lying and being situated in the City of Hawk Point, Missouri, County of Lincoln, State of Missouri, are hereby vacated:

ALL OF THE ALLEY IN BLOCK 6 IN THE FIRST ADDITION TO HAWK POINT, LINCOLN COUNTY, MISSOURI, RECORDED IN PLAT BOOK 2, PAGE 31.

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM ITS PASSAGE AND APPROVAL.
